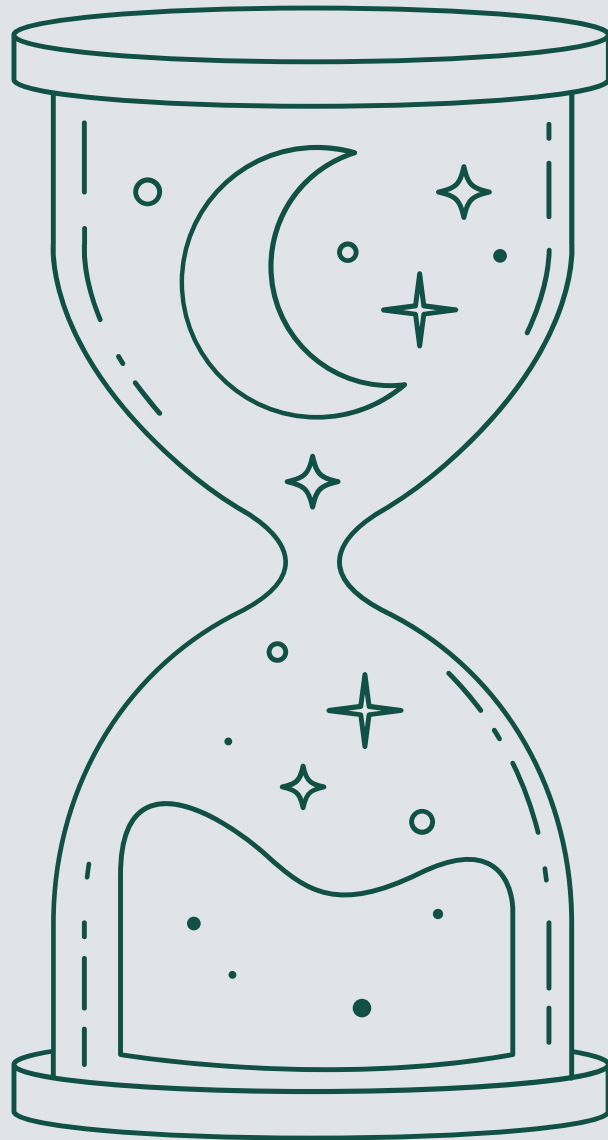


My Time's Run Out
